## Attachment to application to address Council on September 9, 2019

## Key points of presentation:

On-street parking in The Village has recently become an issue again. Due to the unique architectural and design features of The Village that embrace the concept of New Urbanism, the vast majority of homeowners have just two parking spots; typically a parking pad and a garage or a two car garage located in a laneway. For those with two cars, there is no parking available for overnight guests other than the street. It is our understanding that recent ticketing has been a result of complaints by two or three individuals. As a result, the Town has been ticketing cars throughout the community if they have been in one spot more than 12 hours.

As the Town embraced the concept of New Urbanism and participated in developing and approving the plans for The Village as an attractive entrance to Old Town without any accommodation for guest parking other than street parking, we are asking that we work together to consider ways in which we can allow street parking and avoid having our guests and family members ticketed when they come to stay.
