BY-LAW NO. 4512A-21

A BY-LAW TO AMEND BY-LAW NO. 4512-11 OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE RESPECTING ANIMAL CARE AND CONTROL

WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 4512-11 on December 12, 2011;

AND WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

AND WHEREAS the Town of Niagara-on-the-Lake considers it desirable to have one administrative penalty system for all non-parking related offences;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE ENACTS AS FOLLOWS:

- 1. That Schedule "C" attached to By-law No. 4512-11 be deleted and replaced with Schedule "C" attached hereto;
- 2. That By-law No. 4512-11 be amended by adding the following Section to OFFENCES AND PENALTIES:

OFFENCES AND PENALTIES

- 97. Any person who contravenes this By-law may be issued an administrative penalty in accordance with the AMPS By-law No. 5306-21 for Non-Parking Offences in accordance with Schedule "C" attached hereto and forming part of this By-law.
- 3. That By-law No. 4512-11 be amended by renumbering the following Sections:

INTERPRETATION

- 98. Where a Court of competent jurisdiction declares any section or part of a section of this By-law invalid, the remainder of this By-law shall continue in force and effect unless the Court makes an order to the contrary.
- 99. The schedules attached hereto shall form part of this By-law.

ENACTMENT

- 100. By-law No. 2948-95, as amended, is hereby repealed.
- 101. This By-law shall come into force and take effect upon the date of passage.

SHORT TITLE

- 101. This By-law may be referred to as the "Animal Care and Control By-law".
- 4. That this by-law come into force and effect upon the passing thereof.
