### BY-LAW NO. 5172A-21

A BY-LAW TO AMEND BY-LAW NO. 5172-19 TO REGULATE THE SALE OF AND USE OF FIREWORKS WITHIN THE TOWN OF NIAGARA-ON-THE-LAKE

**WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5172-19 on July 15, 2019;

**AND WHEREAS** the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

**AND WHEREAS** The Town of Niagara-on-the-Lake considers it desirable to have one administrative penalty system for all non-parking related offences;

#### NOW THEREFORE BE IT ENACTED AS A BY-LAW OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE as follows:

- 1. That By-law No. 5172-19 be amended by adding Schedule "A" attached hereto.
- 2. That By-law No. 5172-19 be amended by adding the following Section as 9(b):
  - 9(b) Any person who contravenes this By-law may be issued an administrative penalty in accordance with the AMPS By-law 5306-21 for Non-Parking Offences in accordance with Schedule "A," attached hereto and forming part of this By-law
- 3. That By-law No. 5172-19 be amended by renumbering Section 9(b) and (c) as follows:
  - (c) costs associated with the Fire Department response to the contravention, as determined by the Fire and Emergency Services Fee Schedule, in effect at the time of the attendance by the Fire Department, will be billed to the property owners regardless of whether the Fireworks were discharged with the permission or knowledge of the property owner or by granted Approval, and if not paid within a reasonable amount of time, will be added to the property taxes for the property, and same shall be collected in the same manner as taxes in accordance with Section 446 of the Municipal Act, 2001, S.O. 2001, c. 25, as amended.
  - (d) Neither the Fire Department nor the Town shall be responsible to notify the owner of a property, in advance, of its intention to charge for services or costs associated with the response to the Discharge of Fireworks.
- 4. That this By-law shall come into force and take effect immediately upon the passing thereof.
