TREE APPEAL - 5:00 PM

(1) 51 Colonel Butler Crescent - Eric & Lillian Forsyth

Kristina Toppazzini Urban Forestry & Municipal Law Enforcement Officer explained that the application was to remove seven (7) spruce at 51 Colonel Butler Crescent. The property was inspected and noted to be in good condition with no major defects. She stated that the one point was there was over crowding in a small backyard. She further stated there was nothing apparent to permit the trees an exemption from being removed. Ms. Toppazzini answered questions from Council.

Eric & Lillian Forsyth, 51 Colonel Butler Crescent

Mr. Forsyth stated that what Ms. Toppazzini stated was true but the dominate the

property even with pruning. He stated the backyard is 50 feet x 75 feet and the trees take up about 860 feet of that space. He also noted the roots are near the surface, and are creeping across the property. Also noted was the neighbours had provided letter with concerns of the trees falling. They stated they would like to replace these trees with 15 native cedar and 2-3 service berry trees.

THEREFORE, BE IT RESOLVED, that Council direct staff to bring a report to Council outlining the cost and benefits (revenue potential) of implementing a licensing division to administer the various applications, administration, licensing and enforcement in the Town and that these should include, but not be limited to, the issuance of dog licences, short-term rental licences, special events licences, various parking passes, and any new potential revenue ideas such as marriage licences, etc.

AND that this report is prepared in time to bring to the Audit and Finance Committee for discussion in the 2022 budget cycle, if time permits, with potential implementation in 2022.

WHEREAS Niagara-on-the-Lake has recently entered into an agreement with Honk Mobile to assist in facilitating parking payments,

AND WHEREAS, currently Niagara-on-the-Lake currently provides a one-hour parking pass to all residents for parking in Old Town,

AND WHEREAS, some residents have indicated issues with the current 12-hour parking limit on Town streets,

AND WHEREAS Honk Mobile can provide a multitude of parking pass options at various rates for hourly, daily, weekly, monthly etc.

THEREFORE, be it resolved that Council direct staff to prepare a report to Council in time to make recommendations to the Audit and Finance committee for budget deliberations for fiscal year 2022,

AND FURTHER that the report includes a cost benefit analysis of introducing daily, weekly and monthly passes that would allow parking beyond the 12 hour no parking limit during the period of 8pm to 8am daily and without impacting the current one-hour pass or removing the current 12 hour no parking requirement. Residents would still be able to park on Town streets between 8 am and 8pm daily without requiring a pass,

AND FURTHER that this item be considered a one year pilot program and be combined with Item No. 5 on the "Outstanding Items List, Niagara-on-the-Green Parking Permit Report", dated May 20, 2021.
