BY-LAW NO. 5211-20**

**A BY-LAW TO APPOINT JAY PLATO DEPUTY FIRE CHIEF –
COMMUNITY RISK REDUCTION - AND MUNICIPAL LAW
ENFORCEMENT OFFICER FOR THE CORPORATION OF THE
TOWN OF NIAGARA-ON-THE-LAKE AND RESCIND BY 4951-17**

WHEREAS Section 6 (1) of the Fire Protection and Prevention Act, S.O. 1997, c.4 provides that if a fire department is established for a municipality, the Council of the municipality shall appoint a Fire Chief for the Fire department;

AND WHEREAS The Corporation of The Town Niagara-on-the-Lake did appoint a Fire Chief through By-law 5184-19;

AND WHEREAS The Corporation of The Town Niagara-on-the-Lake did hire Jay Plato – Deputy Fire Chief – Community risk Reduction on January 1, 2020;

AND WHEREAS Section 15(1) and 15(2) of the Police Services Act, R.S.O. 1990, c.P.15, as amended, allows for municipal councils to appoint persons to enforce the by-laws of the municipality being Municipal Law Enforcement Officers as Peace Officers for the purposes of enforcing municipal by-laws;

AND WHEREAS the Council of The Corporation of the Town of Niagara-on-the-lake deems it desirable to appoint Municipal Law Enforcement Officers for the purpose of enforcing the by-laws of the municipality.

NOW THEREFORE the Council of The Corporation of The Town of Niagara-on-the-Lake enacts as follows:

1. That Jay Plato be appointed as Deputy Fire Chief – Community Risk Reduction - for Town of Niagara-on-the-Lake effective January 1, 2020;
2. That Jay Plato be and is hereby appointed as Municipal Law Enforcement Officer for the purpose of enforcing the Parking By-law of The Corporation of the Town of Niagara-on-the-Lake specifically dealing with Fire Routes and Fire Hydrants, as outlined in the Corporation's Private Parking By-law; and such appointment to take effect upon the said Jay Plato subscribing an oath in the form of Schedule "A" to this by-law; and
3. That the Municipal Law Enforcement Officer named herein shall be responsible for the enforcement of all Parking By-laws of the Corporation of the Town of Niagara-on-the-lake, as may be directed by Council or the Supervisor of By-law Enforcement; and
4. That By-law 4951-17 be rescinded; and
5. That this by-law shall come into force and take full effect from the date of passing thereof.
