BY-LAW NO. 4308AM-21

A BY-LAW TO AMEND BY-LAW NO. 4308-09, AS AMENDED, BEING A BY-LAW REGULATING TRAFFIC AND PARKING ON TOWN ROADS; AND TO AMEND THE FOLLOWING SCHEDULE: Schedule C and Schedule W

WHEREAS The Council of The Corporation of the Town of Niagara-on-the-Lake approved By-law No. 4308-09 on the 8th day of June 2009;

AND WHEREAS Section 11 of the Municipal Act, R.S.O. 2001, Chapter 25, authorizes the Council of a Municipality to pass by-laws respecting highways, including parking and traffic on highways;

AND WHEREAS Municipalities may pass by-laws under the provisions of the Highway Traffic Act, R.S.O. 1990, c H8;

AND WHEREAS Council adopted the recommendation that the speed limit on Concession 6 Road between York Road and Queenston Road be reduced to 60 km/hr on November 22, 2021;

AND WHEREAS Council adopted the recommendations contained Operation Services Report OPS-21-030 to implement parking prohibitions at John Street West @ Gate Street.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE enacts as follows:

1. That Schedule “C” (Parking Prohibitions) attached to By-law No. 4308-09, be amended by adding the following:

2. That Schedule “W” (Speed Limits) attached to By-law No. 4308-09, be amended by removing the following:

3. That Schedule “W” (Speed Limited) attached to By-law No. 4308-09, be amended by adding the following:
