6. COVID-19 UPDATE

Marnie Cluckie, Chief Administrative Officer provided the following update for the Committee:

- Province still in Step 3 of Roadmap to Reopen
- As of December 9 90% of Ontarians 12 and over received first dose, 87% with complete series, and 25% of children 5-11 years received first dose
- Omicron variant significant impacting case count
- Province adjusting COVID response
- Proof of vaccination for youth 12-17 years participating in sports
- strongly advising limitation with social gatherings
- Province encouraging employers to continue to allow work from home
- Province put a pause on lifting capacity limited in higher risk settings
- Section 22 permits municipalities to enact by-laws to target specific transmission risks
- December 13th people 50 an over eligible for the booster, January 4th 18 years and old eligible
- Niagara Region stats 79.9% first dose and 75.9% with a complete series
- 17 people currently in Niagara hospitals
- 9% decrease in traffic with 73 parking tickets issued
- Non-compliant STRs decreased by 99%
- Impact of high winds resulted in power outages, downed hydro lines and leaning poles
- Operations crew worked with Hydro to guickly mitigate issues
- Santa around Town was moved to Sunday December 12th
- December 18th Santa coming to Town hosted by NOTL Palliative Care

CS-21-034 Noise By-law Exemption for the Regional Municipality of Niagara (Region) Niagara Stone Road (Regional Road 55) Reconstruction

Moved by Councillor Norm Arsenault that the recommendation contained in Corporate Services Report CS-21-034 be approved as follows:

1.1 An exemption to Noise Control By-law No. 4588-12, Schedule C - #4 be granted to the Regional Municipality of Niagara, to allow construction to take place from 6:00 a.m. until 11:00 p.m. for the Niagara Stone Road (Regional Road 55) Reconstruction project between Four Mile Creek Road and East and West Line, scheduled to begin in the spring of 2022.

OPS-21-030 All-Way Stop Control Investigation - John Street West @ Gate Street & Parking and Traffic Bylaw Amendments

Moved by Lord Mayor Betty Disero that the recommendations contained in Operation Services Report OPS-21-030 be approved as follows:

1.1 Council approve the implementation of the following parking controls along the following streets as shown in Appendix I, attached hereto:

Gate Street

- a) The east and west sides of Gate Street to 15 m north of John Street West.
- b) The east and west sides of Gate Street to 15 m south of John Street West.

John Street West

- a) The north and south sides of John Street West to 15 m west of Gate Street.
- b) The north and south sides of John Street West from Gate Street to Victoria Street.
- c) The north and south sides of John Street West to 15 m east of Victoria Street.

Victoria Street

- a) The east and west sides of Victoria Street to 15 m north of John Street West.
- b) The east and west sides of Victoria Street to 15 m south of John Street West.
- 1.2 The Town Clerk be directed to amend "Schedule C Parking Prohibitions" of the Traffic and Parking By-law 4308-09 to provide for the above-noted parking prohibitions; and
- 1.3 The Town installs the necessary signage to implement the parking control measures at an estimated cost of \$2,500, to be charged to the Roads Department operating budget sign account.
