#### **PRESENTATIONS**

## (1) Lord Mayor Volunteer Awards Presentation

Lord Mayor Betty Disero opened the presentation by welcoming everyone to the 2021 Volunteer Awards. The Lord Mayor stated the volunteers in our community are such an important part of Niagara-on-the-Lake, and we are extremely fortunate to have so many dedicated volunteers in this Town.

These awards are meant to acknowledge, honour and congratulate the volunteers in our Town who have been nominated. Thank you to everyone who took the time to fill out a nomination form and thank you to everyone in this Town who takes time, no matter how long or short, to volunteer and make a positive impact on

Niagara-on-the-Lake. Today, we will be presenting ten awards to ten individuals who were selected by a Selection Committee based on the information provided in their nomination form

- (i) Community and Civic Engagement Award awarded to Jim and Marilyn Armstrong by Councillor Norm Arsenault. Their passion for preserving history at a community level led Jim to establish and be President of the Queenston Residents' Association, and Marilyn became the Chair of Fundraising. This Association encourages residents coming together, preserving heritage, celebrating culture and protecting the environment. Along with leading the Queenston Residents' Association, Jim and Marilyn were also nominated for their various commitments to the community over the years. One example is their development of "Friends of Queenston," a group which organizes cleanups on Earth Day. The Armstrongs would like to specially recognize the Queenston Residents' Association Members and Directors, whose hard work makes their volunteer efforts possible.
- (ii) Culture Award awarded to Lise Andreana by Councillor Al Bisback. Lise was nominated for her extraordinary job supporting the visual arts sector in Niagara-on-the-Lake as a volunteer Chair of the Niagara Pumphouse Arts Centre. Lise is known to always elevate the quality and accessibility of visual arts here in Town.
- (iii) Environmental Efforts Award awarded to Kyra Simone by Councillor Gary Burroughs. Kyra was nominated for her leadership on countless environmental initiatives, from educating locals on environmentally friendly tips, to leading cleanup efforts in public places, to conducting environmental research to provide useful findings for the general public. Kyra's creativity in the events she organizes has a big impact on the community. Kyra's educational background in Science and Science Communication, combined with her love for her home town, make her the perfect candidate for this award.
- (iv) Diversity, Equity and Inclusion Award awarded to Niki Walker by Councillor Clare Cameron. Niki was nominated for her efforts as Co-Chair of the Diversity, Equity and Inclusion Committee. Niki is described as the heart and soul of the Committee, bringing people together and making great things happen. Niki's work has benefitted the Town and residents, making a positive and important impact on the community.
- (v) Sports & Recreation Award awarded to Rosemary Goodwin by Councillor Wendy Cheropita. Rosemary is known for actively promoting and introducing members of our community to tennis in Niagara-on-the-Lake, as her passion for tennis knows no bounds. Rosemary can also be found supporting many community activities, including the Terry Fox run.
- (vi) The Volunteer under 16 Award awarded to Samantha Fretz by Councillor Sandra O'Connor. Samantha was nominated for her active role in the community in helping

others. She has donated her hair three times for wigs for kids programs. She's a member of the Lord Mayor's Youth Advisory Council, has helped arrange activities/events to get the community engaged and raise awareness about important topics, and so much more. From creating a COVID-19 safety and mental health video, to organizing virtual game nights, to packing and handing out bags for youth wellness, Samantha is an important member of the Niagara-on-the-Lake community.

- (vii) Volunteer under 30 Award awarded to Carrie Robinson by Councillor Sandra O'Connor. Dedicated and passionate about the Niagara-on-the-Lake community, the winner of this award goes to Carrie Robinson. Carrie was nominated for the inspiration she provided to others at the third annual Daughters of the Vote conference. Carrie has great ideas and suggestions to help keep young people in Niagara-on-the-Lake. She works closely with her peers to lobby for affordable housing in the community.
- (viii) Seniors Award awarded to Tim Taylor by Councillor Norm Arsenault. Tim was nominated for his efforts in raising money for Niagara-on-the-Lake Palliative Care over the years through long-distance bicycle rides. It was noted that one can see him on the street every day, riding to meet sponsorship requirements, and that he is committed to being the Santa Claus for Palliative Care. Tim has also helped raise money for the Long Term Care program with the Healing Cycle.
- (ix) Youth / Education Award Caitlyn Neufeld by Councillor Clare Cameron. A volunteer with Cornerstone Community Church's youth program for more than 5 years, this award goes to Caitlyn Neufeld. Caitlyn has been volunteering with Cornerstone Community Church's youth program for more than 5 years. Caitlyn spends her Thursday evenings and most Sunday mornings serving 30 to 40 youth and engaging with them in activities and meaningful peer relationships. Over the years, Caitlyn has planned and led so many events for kids to enjoy, including sports, movie nights and outings. Caitlyn accepts this award on behalf of the other Cornerstone Junior Youth volunteers, who volunteer weekly at Cornerstone Community Church, in Virgil. Caitlyn does all of this while working and studying Child and Youth Studies at Brock University.
- (x) Council Appreciation Award awarded to Joan King by Lord Mayor Betty Disero. Joan was nominated for her dedication to the Terry Fox run, raising over \$1 million since her first run in 1991. Joan volunteers for other events in Niagara-on-the-Lake and is always looking for ways to raise money for our small community. Joan's dedication to the Niagara-on-Lake community, her drive for Town improvements and her passion for people make her the perfect candidate for this special award.

Lord Mayor Betty Disero and Members of Council congratulated all of the volunteers who won an award. There were many other individuals nominated for our Volunteer Awards this year, and appreciation toward those residents as well is given as well. Niagara-on-the-Lake is extremely fortunate to have such a caring, thoughtful and

WHEREAS, the Town of Niagara-on-the-Lake's (NOTL) Community Vision as defined in our Operating Plan states in part that "We are a community for everyone. We are a resilient, distinctive and dynamic Town in which to live, work and learn. Through responsible stewardship, we preserve the balance of values that make us a world-class destination. Although we dream big, we stay true to our small-town roots";

WHEREAS NOTL is recognized around the world as a much-desired travel destination for its heritage value, rich tapestry, fine wines, exceptional cuisine, and a lifestyle that is second to none;

WHEREAS, the tourism and agricultural industries in NOTL require a substantial number of service workers to work in our fields, in our wineries, in our restaurants and the accommodation sector;

WHEREAS, the Niagara Regional Summit recognized that a 15-minute city is both desirable and a necessary goal that will allow all of our workers to work and live in the community they serve;

WHEREAS, in order to accomplish such a goal, workers need to be able to make a living wage that will allow them the possibility of attaining that goal;

WHEREAS, many businesses in Town are struggling to attract and keep a workforce that provides services to our burgeoning tourism sector, in part due to wages that do not provide a living wage as determined by the Ontario Living Wage Network (OLWN). A living wage is the hourly wage a worker needs to earn to cover their basic expenses and participate in their community and is currently \$18.90 per hour; and

WHEREAS, the approximate cost of implementing a living wage of \$18.90 in 2022 for the Town and directly associated boards is upwards of \$36,850.

THEREFORE, BE IT RESOLVED that the Council of the Town of Niagara-on-the-Lake wishes to provide leadership on this issue and directs staff to conduct a cost/benefit analysis and bring back an Information Report to Council on the impact of developing and implementing a policy that will ensure that municipal workers receive, at a minimum, a living wage as determined by the OLWN,

AND FURTHER, that staff report back to Council on the impact of implementing a policy that will give preference to contractors and suppliers doing work for and/or on behalf of the Town, who commit to providing their workers with a living wage as determined by the OLWN.

AND, finally, encourage Town employers to review their business models and consider joining the OLWN and commit to implementing a living wage as soon as their

circumstances will allow.
