**BY-LAW NO. 4705-14**

A BY-LAW TO APPOINT THOMAS BOAL AS A MUNICIPAL  
LAW ENFORCEMENT OFFICER, INSPECTOR FOR  
PROPERTY STANDARDS AND AREA WEED INSPECTOR  
FOR THE CORPORATION OF THE TOWN OF NIAGARA-  
ON-THE-LAKE AND TO RESCIND BY-LAW 4612-13, 4614-  
13, 4625-13 AND 4660-13

**WHEREAS** Sections 15.(1) and 15.(2) of the Police Services Act, R.S.O. 1990, c.P.15, as amended, allows for municipal councils to appoint persons to enforce the by-laws of the municipality being Municipal Law Enforcement Officers as Peace Officers for the purpose of enforcing municipal by-laws;

**AND WHEREAS** Sections 3.(1) and 3.(2) of the Building Code Act, 1992, S.O. 1992, c.23, as amended, advise the councils of each municipality are responsible for the enforcement of the Building Code Act in the municipality and the councils shall appoint inspectors as are necessary for the enforcement of the Building Code Act, and the Property Standards By-law, as Property Standards Officers;

**AND WHEREAS** Section 6.(1) of the Weed Control Act, R.S.O. 1990, c. W.5 provides for the appointment of Area Weed Inspectors for the purpose of enforcing the Week Control Act within the municipality.

**NOW THEREFORE** the Council of the Corporation of the Town of Niagara-on-the-Lake hereby enacts as follows:

1. that Thomas Boal is hereby appointed as Municipal Law Enforcement Officer in accordance with the Police Services Act, R.S.O. 1990, c. P.15, as amended, for the Corporation of the Town of Niagara-on-the-Lake for the term of employment as Municipal Law Enforcement Officer;
2. that Thomas Boal is hereby appointed as Property Standards Officer in accordance with Section 3.(1) and 3.(2) of the Building Code Act, S.O. 1992, c.23 for the Corporation of the Town of Niagara-on-the-Lake for the term of employment as Property Standards Officer;
3. that Thomas Boal is hereby appointed Area Weed Inspector in accordance with Section 6.(1) of the Weed Control Act, R.S.O. 1990, c. W.5 for the Corporation of the Town of Niagara-on-the-Lake for the term of employment as Municipal Weed Inspector;

4. that By-laws 4612-13, 4614-13, 4625-13 and 4660-13 are hereby rescinded;
5. that this by-law shall come into force and effect upon the passing thereof;
