A BY-LAW TO AMEND BY-LAW NO. 5306-21 TO REGULATE THE USE OF MUNICIPALLY OWNED PARKS

WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5306-21 on March 22, 2021;

AND WHEREAS the Council of The Corporation of The Town of Niagara-on-the-Lake passed By-law No. 5334-21 on June 21, 2021;

AND WHEREAS The Town of Niagara-on-the-Lake considers it desirable to have one administrative penalty system for all non-parking related offences;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE ENACTS AS FOLLOWS:

- 1. That By-law No. 5306-21 be amended by deleting Schedule "A".
- 2. That By-law No. 5306-21 be amended by adding Schedule "A" attached hereto.
- 3. That By-law No. 5306-21 be amended by adding the following to PART 20: ENFORCEMENT No. 4:
 - 4. Any person who contravenes this By-law may be issued an administrative penalty in accordance with the AMPS By-law 5334-21 for Non-Parking Offences in accordance with Schedule "A," attached hereto and forming part of this By-law.
- 4. That this by-law come info force and effect immediately upon the passing thereof.
