**BY-LAW NO. 5346-21**

A BY-LAW TO APPOINT JESSE PAUL AS A MUNICIPAL LAW ENFORCEMENT OFFICER, PROPERTY STANDARDS OFFICER AND AREA WEED INSPECTOR FOR THE CORPORATION OF THE TOWN OF NIAGARA-ON-THE-LAKE

**WHEREAS** Section 15(1) and 15(2) of the Police Services Act, R.S.O. 1990, c.P.15, as amended, allows for municipal councils to appoint persons to enforce the by-laws of the municipality being Municipal Law Enforcement Officers as Peace Officers for the purposes of enforcing municipal by-laws;

**AND WHEREAS** Sections 3(1) and 3(2) of the Building Code Act, 1992, S.O. 1992, c.23, as amended, advise the councils of each municipality are responsible for the enforcement of the Building Code Act in the municipality and the councils shall appoint inspectors as are necessary for the enforcement of the Building Code Act, and the Property Standards By-law, as Property Standards Officers;

**AND WHEREAS** Section 6(1) of the Weed Control Act, R.S.O. 1990, c. W.5 provides for the appointment of Area Weed Inspectors for the purpose of enforcing the Weed Control Act within the municipality.

**AND WHEREAS** the Council of The Corporation of the Town of Niagara-on-the-Lake deems it desirable to appoint Municipal Law Enforcement Officers, Property Standards Officers and Weed Inspectors for the purpose of enforcing the by-laws of the municipality.

**NOW THEREFORE the Council of The Corporation of The Town of Niagara-on-the-Lake enacts as follows:**

1. That Jesse Paul is hereby appointed as Municipal Law Enforcement Officer, Property Standards Officer and Weed Inspector for the purpose of enforcing municipal by-laws, in accordance with the Police Services Act, R.S.O. 1990, C.P.15, as amended, Building Code Act, 1992, S.O. 1992, c.23, and the Weed Control Act, R.S.O. 1990, c. W.5, for The Corporation of The Town of Niagara-on-the-Lake for the term of employment as Municipal Law Enforcement Officer.
2. THAT this by-law shall come into force and effect upon the passing thereof.
